Public Opinion Survey



During the month of April 2024, the Planning Board conducted a public opinion survey of Seabrook residents to solicit their views on a wide range of issues that will impact the community in the future. The board's intent in soliciting public input is to ensure that the master plan reflects the views and sentiments of a majority of townspeople. Thank you to all who participated. We are in receipt of 540 responses! That is a great response.

The survey had 25 questions, and in many cases, additional comments were welcomed to supplement the responses to most of the 25 questions. Respondents left 2,484 such comments, all of which are readily accessible on the project website at https://seabrookmp.online/survey.




Images 1 & 2. Repositories for paper survey forms at the library (above) and at the Town Offices (right).











Q14 What types of additional programming would you like to see? (Select all that apply)






Image 3. Sign at the Rail Trail entrance situated off Collins Street.






Privately Owned & Operated Solar Farms





Q20 If your adult children wish to reside in Seabrook, can they afford to do so?





Q21 Have you, or anyone with whom you are acquainted, had a difficult time finding housing in Seabrook?





Q22 In the place where you currently reside, do you feel that:






